#### Additional details relating to the baseline emissions calculations.

This is the first time we have reported our carbon footprint, so this calculation establishes our baseline. It is based on the period from November 2023 to October 2024.

Our Baseline calculation includes:

- Scope 2: Indirect Emissions
- Scope 3 Categories: 1: Purchased goods and services: 3: Fuel and energy related activities: 4: Upstream transportation & distribution: 5: Waste generated in operations: 6: Business travel/Hotel stays: 7: Employee commuting/Teleworking: 8: Upstream leased assets.

Our Baseline deviates from the requirements under PPN 06/21 as follows:

- Scope 1: Direct Emissions is not included as heating is included in scope 2 energy, no fuels of biological origin, no processes or equipment that directly release greenhouse gases, there were no company vehicles. Scope 3: Category 9: Downstream transportation & distribution: is not included as no transportation paid for by customers.
- Scope 3: Category 1: Purchased goods and services: is included as IT support, software & health Services. Scope 3: Category 3: Fuel and energy related activities: is included as upstream emissions from fuels/energy and T&D losses are included. Scope 3: Category 8: Upstream leased assets: is included as AWS spend.


